

Privacy and Cookie Policy

This Privacy and Cookie Policy explains how personal data are processed, stored and accessed on User Devices by the Website operated by the Controller for the provision of electronic services by the Controller.

1. DEFINITIONS

1.1. Website – the website operated by the Controller.

1.2. External Websites – the websites operated by the Controller’s business partners, contractors and/or clients.

1.3. Controller – Fusioncopter Sp. z o.o., with its main office in Warsaw, postal code 02-284, at Aleja Krakowska 22A, registered by the 13th Commercial Division of the District Court for the Capital City of Warsaw under KRS number: 0000417187, NIP 951-23-55-053, REGON 146075772, a company which offers electronic services via the Website, stores and accesses information on User Devices.

1.4. Cookie (cookie) – IT data, mainly in the form of small text files, which are stored on the User Devices. Cookies typically include the name of the web page, length of storage on the User Devices and a unique identifier.

1.5. Personal Data – particulars of an individual as defined in the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (GDPR).

1.6. Domain Name – a string of text that identifies the address of a given website.

1.7. User – an individual to whom the Controller provides electronic services via the Website.

1.8. Device – an electronic device with software enabling the Users to access the Website.

2. HOW INFORMATION IS COLLECTED

The Website collects information about the Users and their activity in the following ways:

- a. by placing cookie files on the Device,
- b. by collecting server log files by the Controller.

3. PERSONAL DATA

3.1. Unless expressly indicated otherwise, the personal data provided by the Users while using the Website are administered by the Controller.

3.2. The personal data provided by the Users while browsing the Website are processed in order to:

- a. allow using the Website in accordance with its functionality;

- b. improve the Website's operation;
- c. prepare statistical information and analytics;
- d. detect cases of prohibited use of the Website, determine liability and seek damages.

3.3. In processing the Personal Data, the Controller may use subprocessors acting on the Controller's behalf. Such subprocessors may only process the data for the purposes defined by the Controller.

4. INFORMATION ON COOKIE FILES

4.1. Cookie files can be placed and accessed on the User Devices by the Controller.

4.2. The methods in which cookie files are stored and read do not allow any data or confidential information to be retrieved from the User Devices without the User's consent.

4.3. We use the following types of cookies on the Website:

- a. essential cookies, which allow the use of services offered by the Website, such as authentication cookies used for services which require user authentication on the Website to maintain the session (after logging in); in this way, the Users do not need to enter their login and password on every Website page
- b. security cookies, used e.g. to detect fraudulent authentication within the Website
- c. performance cookies, used to collect information on how the Website's pages are browsed
- d. functionality cookies, which enable the Website to "remember" the User's settings and personalise the User's interface, for instance the selected language or region, font size, webpage layout, etc.
- e. advertising cookies, which help providing the Users with advertising content consistent with their preferences (profiling).

4.4. The Users can also receive cookies while visiting websites operated by our business partners. The use of cookies on such third-party websites is governed by their own privacy and cookie policies.

4.5. The terms for storing and obtaining access to the User Devices by the Website are as follows:

- a. the Users may change the settings for the recording, removing and accessing the data of the recorded cookie files at any time
- b. the Users may delete all the recorded cookies by using the tools offered by the Device through which the Users access the Website
- c. information on how cookies can be turned off in the most popular browsers and on mobile devices can be found at: jakwylaczycookie.pl.

4.6. The Website requirements are as follows:

- a. restricting the recording and accessing of cookies on the User Devices can affect some of the functionalities available on the Website
- b. the Controller shall not be held liable for any faulty Website functionality if the Users restrict the placing and reading of cookies in any way.

5. SERVER LOG FILES

5.1. Information on some of the Users' activities is server-logged. Such data are used to operate the Website and ensure an efficient service provision.

5.2. The browsed Website content is identified by URL addresses. Other information which may be collected includes the following:

- a. the time of receiving the order or request
- b. the time of sending the reply
- c. the Device
- d. information on errors which occurred while browsing the Website
- e. the address of the webpage last visited by the User (referrer or origin link)
- f. information on the User's interactions on the Website
- g. information on the User's browser,
- h. information on the IP address,
- i. information on the User's location,
- j. the length of access.

6. ACCESS TO THE DATA

6.1. The data can only be accessed by external bodies within the limits permitted by law.

6.2. The Controller may be obliged to share the information collected by the Website with the authorised bodies based on lawful requests and within the required scope.

6.3. The Controller can allow the entity succeeding the Controller in his rights and duties connected with the Website access to the Users' Personal Data. In such an event, the Users will be notified about the new controller of their Personal Data in accordance with the applicable regulations.

7. CHANGES IN THE PRIVACY AND COOKIE POLICY

7.1. The Controller reserves the right to make changes in this Privacy and Cookie Policy. The version of the document which is currently in force can be found on the Website.

7.2. The change of language of this Privacy and Cookie Policy shall not be deemed as a change of this document.
